Applications must be processed locally (Juan de Fuca Recreation Centre), after which the 52 Drop-in and Coupons Drop In Admissions Card may be used at any Recreation Centre in Greater Victoria. The annual pass option is restricted to the Juan de Fuca Recreation Centre you purchased it at.

Complete one application per household and drop off with the receptionists at the Juan de Fuca Recreation Centre, 1767 Island Highway, Victoria BC 250-478-8384 2. Bring current identification such as Care Card, BC ID, Drivers License. 3. Bring current proof of residency with you, such as, utility bill or rental agreement. 4. Bring proof of gross annual household income, previous years income tax. 5. L.I.F.E. Cards will be issued to each member of an eligible household. The L.I.F.E. Cards are good for one calendar year. 6. Your LIFE application will be processed within a 7 to 10 day period, and once approved, an approval letter will be mailed to you at the mailing address provided on your application form.
